

PRIVACY POLICY of 3G Bikes Germany

§ 1 General

Your personal data (e.g. title, name, address, email address, telephone number, bank details, and credit card details) are processed by the 3G Bikes Germany only according to the regulations of the German data privacy laws. The subsequent regulations inform you about the manner, extent and purpose of the acquisition, processing and usage. This privacy policy only relates to the websites of 3G Bikes Germany. In case you are routed from the 3G Bikes Germany websites to other websites, please inform yourself about the corresponding extent of your data.

§ 2 Automatic Data Acquisition

Due to technical reasons the following data et al. are collected, which are transmitted to us by your Internet browser:

- browser type and version
- operating system in use
- websites which referred you to the website of 3G Bikes Germany (Referrer URL)
- websites that you visit
- date and time of your access
- your Internet protocol (IP) address.

These anonymous data are stored disconnected from your eventually entered, personal data and do not enable to draw any conclusions about a certain person. The data are evaluated because of statistical purposes, in order to improve the Internet presence and the corresponding offers of the 3G Bikes Germany. The data are deleted immediately after the statistical evaluation.

§ 3 Stock Data

(1) Your personal data, as long as they are required for the reasoning, content form or change of a contractual relationship (stock data), are solely used for the settlement of the contract. So e.g. your name and address has to be given to the forwarder for the shipment of the goods. Your personal data will not be given to any third parties without your explicit agreement or without a legal basis.

(2) By ruling of the relevant authorities, 3G Bikes Germany is allowed to give away information about the stock data in particular cases, as long as this is required for the purposes of prosecution, for the danger defense by the police departments of the country, for the performance of legal tasks by the Federal Office for the Protection of the Constitution of Federation and countries, the Federal Intelligence Service or the Military Counter-Intelligence Service or for the realization of the rights for intellectual property.

§ 4 Informationen about Cookies

(1) So-called Cookies are implemented for the recognition of the repeated use of an offer by the same user. Cookies are small text files which are stored and saved on your PC by your Internet browser. When you access the websites of the 3G Bikes Germany again, these Cookies provide information in order to automatically recognize you. The recognition is due to the IP address stored in the Cookies. The obtained information provides the basis to optimize our offers and to enable an easier access to our websites.

(2) You can avoid the saving of Cookies on your hard drive by choosing „accept no cookies“ in your browser settings. Nevertheless, this might cause a functional limitation of the services and offers of the 3G Bikes Germany.
